December 2015: Save our Poinciana trees

A public meeting in Liverpool Street, Clayfield, was arranged by north-side member, Jim Butler, to discuss the management of our Poinciana street trees. They face an uncertain future due to their age, monoculture (we can't do anything about these) and now the ravages of the green caterpillars (we may be able to act here). Cr McLachlan was invited to attend.

February/March 2016: pre-1911 Highgate Hill houses, Brisbane AGHS made a submission to the Queensland Heritage Council in response to the nomination for listing of three clearly pre-1911 Highgate Hill houses, which BCC had not entered into the relevant town plan overlay, and for which the developers of the site, using a private certifier, had demolition approval [even though the property owners were aware

The focus of the submission was to urge the heritage council to use the powers it has within the Heritage Act to advise local council and to encourage appropriate management, with regard to BCC, so as to achieve better outcomes for garden and streetscape heritage. At its meeting on 11 April the heritage council decided not to list these buildings, and made no response to the society's submission regarding the use of its other powers.

Two of the four houses have subsequently been demolished, and all vegetation, including the old bougainvillea hedge & mature frangapani, as well as the top soil, have been removed. The site is now exposed sub-soil.

April 2016: Toowoomba forum: Trees, gardens and urbanization

Please attachment 2 for article about the forum and the issues to be covered in the Toowoomba Chronicle. Committee member, Wendy Lees worked extremely hard to bring about this forum, and with Liz Chappell, from the New England branch, to arrange a weekend of joint garden/park visits in Toowoomba, Pittsworth and Allora. New England branch's experience around "Lost gardens of Armidale" was part of the forum.

The forum took the form of a series of short talks followed by discussion, and was held Friday 15 April 1:30 to 3:30pm, within the house at Boyce Gardens. This originally private house & garden were given to the University of Queensland, and entered later on the Queensland Heritage Register. The forum was followed by afternoon tea, and a tour of Boyce Garden.

Prior to the local government election, a number of Toowoomba local government candidates were asked what they stood on the following AGHS proposals:

- a. forming a register of significant gardens and trees so that development applications on such properties set a flag for heritage management and/or recording activities
- b. the employment of a part-time garden history advisor to provide free advice to property owners in Toowoomba as to the creation and maintenance of pre-WW2 gardens
- c. Implementing a tree protection policy for street, park and garden trees in Toowoomba.

A newly elected councilor, who made a tree register part of her platform, attended the forum, as well as Toowoomba AGHS members, including Alison Curtis. A warm welcome back is extended to Alison, who re-joins AGHS activities following a 15 year "break" packed full of raising children and doing interesting work in environmental & strategic planning with TRC, and who is now based at the University of Southern Queensland. Other Toowoomba locals included the new owners of heritage-listed "Fernside" [interested in meeting others supportive of historic gardens] & those involved in Toowoomba street tree planting and maintenance.

Our speakers were:

- **David Snow,** a long-standing RE agent for the prestige Toowoomba market & REIQ executive member. David spoke eloquently on the importance of trees in unit development and land sub-division, for the wealth of those projects, and of the significance of trees to the character and amenity of Toowoomba.
- **Graham Wilson**, from the New England branch, who spoke about 'what is heritage", and carrying out community education around heritage values through the "Lost gardens of Armidale" exhibition.
- **John Taylor**, AGHS member and former chair of the AGHS National & Queensland committees, spoke on the ideas contained in the phrase "urban forest", and the benefits of cooling provided by trees found on public and private land. The urban forest, with a 40% tree cover, can mitigate completely the heat sink of cities the 2C higher temperature cities acquire compared to their surrounding countryside, caused by the heating up, and re-radiation, of heat from masonry, etc.

The Queensland branch committee thanks members Wendy Lee, John Taylor, Graham Wilson and Liz Chappell without whose efforts this forum and week-end of joint activities would not have been possible.

The committee is looking at how to maintain advocacy around trees & gardens in the Toowoomba area. One idea is a Toowoomba working group comprised of Toowoomba & region members, with Wendy Lees acting as the branch committee liaison.

In addition, *Abbotsford*, an 1870's timber house with attic windows, was originally the neighbour to *Abbotsleigh*, and its existence now hangs on with a thread.

Recently, 5 surrounding houses in Abbotsford Road were demolished or removed in readiness for an 8 storey, 150 apartment-development. The development approval requires that the heritage-listed *Abbotsford* remain. It is currently parked on the block, awaiting the development to commence. The garden is history.



TOOWOOMBA is known for its beautiful gardens.

But the Australian Garden History Society Toowoomba branch is afraid our city is losing its garden heritage.

The society is raising concerns about the rapid loss of our city's beautiful trees and gardens.

Society member Wendy Lees said new developments were mainly to blame.

"As new development comes in and blocks are subdivided the existing trees and gardens are being removed and there is little room to replace them," she said.

"Because of this, the character of the inner city is dwindling and it used to be so alive. Gardens that have taken decades to expertly create to soften architecture and modify the climate are being destroyed in days."

The society would like a garden advisory service set up by the Toowoomba Regional Council, where a specialist is employed to

educate developers and home owners.

"At the moment the council has a garden advisory brochure but no one specialising in that field," she said.

"Another concern is developers and home owners are removing gardens that have survived for years without water and replacing them with a new garden on a sprinkler system when we should be watching water usage.

"As one of the most beautiful cities in Queensland, Toowoomba's uniqueness is being lost and replace by imported landscapes that have no relevance to the life and history of the city.

"Hopefully before it's too late some protective measures can be put in place."

The society will hold a Trees, Gardens and Urban Development forum on Friday, April 15 at Boyce House to address these issues.

The event will be followed on Saturday, April 16 with a coach tour around the city's parks.
