# Chairman's Report

The Society has had a challenging year 2016/17 and the National Management Committee was required to spend considerable time examining carefully the management and structure of our business operation as well as considering at its Annual Planning Day how we should use our 40th anniversary in 2020.

The annual conference was a high point. Its Canberra-centric theme *The Scientist in the Garden* was highly engaging and a great success. The program of speakers and the garden visits served to remind us of the entwined nature of science and gardening, especially in the development of our national capital since its establishment last century. The conference also reflected the need for us to be vigilant in sustaining our cultural landscapes today through advocacy. There were many high points in the conference but the dinner speech delivered by Marion Halligan proved an inspired choice for her evocation of suburban gardening and its bountiful rewards in Canberra circa 1960.

In the second half of the year our National Executive Officer resigned. Phoebe La Gerche-Wijsman had served the Society for five years and brought the organisation more fully into the digital era. Her efficient and effective management of the national office was greatly appreciated, as was her work on developing partnerships with empathetic organisations that served to increase the Society's reputation and influence. When I took up the role of Chairman two years ago it was with the assurance of Phoebe's capabilities as an administrator and her astute awareness of the membership's sensitivities. Our search for a suitable replacement and the interregnum since her departure has revealed our good fortune in having had the benefit of her service.

It was unfortunate that our plans for the 2017 conference to take place in Hamilton, New Zealand, had to be postponed with trans-Tasman plan re-scheduled for 2019. However; the Victorian Branch stepped in to the breach and agreed to host the 2017 conference based in Melbourne, for which we are most grateful.

#### **GOVERNANCE: FINANCE AND MANAGEMENT**

#### **Finance and Investments**

Our financial position continues to be sound, but membership recruitment and retention are still important, and so the National Management Committee (NMC) is encouraging branches to embrace the actions outlined in the Marketing Strategy to continue to increase our membership numbers.

The NMC has established an Endowment Fund to secure the future of the Society and during the year the Finance Sub-Committee tendered advice on how this money should be invested to improve returns at an acceptable level of risk. The Society is grateful to the Committee, including John Dwyer, Alan Read and Tom Hogg, for their support.

#### **Insurance and Risk Management**

The NMC is responsible for ensuring there are adequate policies in relation to overseeing and managing risk and providing adequate public liability and voluntary workers insurance. There were no alterations to these policies this year.

#### **National Management Committee (NMC)**

The NMC met face-to-face on three occasions, in Canberra, Melbourne and Sydney, and held three telephone meetings. In addition to its regular meetings the NMC held a Planning Day in Melbourne in late February 2017.

#### **Gardens + Environment**

Editor Dr Ruth Morgan has worked steadily over the last 12 months seeking co-publishing support from a variety of organisations. Funds from the Nina Crone Fund have been set aside to assist in the future publication.

#### Kindred Spirits Fund

This fund was established in 1999 with the proceeds from the generous bequest of the late Joan Law-Smith of her book *Kindred Spirits* and has been generously supported by a number of our members. Money in the Kindred Spirits Fund is invested with the Myer Family Company and a term deposit. Only the income of the Fund is spent, thereby preserving the capital.

#### **PROJECTS**

Garden Restoration – a Garden Restoration Grant of \$4000 (\$2000 from the SA Branch + \$2000 from the National Office) has been approved to assist long-term AGHS members Dr Ian and Mrs Janie Smylie with the restoration of the circa 1880s gazebo located in their garden at 'Wensleydale', Stirling. The editor of the AGHS journal has already requested a journal article on the restoration, which is being researched and written by member Sandra Kearney.

Garden Recording – The SA branch has undertaken to record the garden at 'The Cedars', the family home of artist Sir Hans Heysen. 'The Cedars' is now owned and managed by the Hans Heysen Foundation and the SA AGHS committee have negotiated our involvement with this iconic SA and national treasure. The initial stage of the recording, a survey of the garden boundaries, the buildings and hard landscaping features is nearing completion. The survey is being done by the Stirling surveying company Olden and van Senden, who are supporting the AGHS initiative by a significant fee reduction.

AGHS Oral History Project – In SA we have a wealth of gardening knowledge, experience, history and stories that have yet to be recorded. Revival of this project in SA has been flagged for action in the near future.

#### SA CHAIRPERSON'S REPORT

I wish to thank SA branch committee for their assistance and support during my first year as Chairperson and the state membership for their participation in Branch activities. The SA branch membership remains steady in number (with 90 – 100 members). The branch has continued to function broadly in support of the mission of the Australian Garden History Society – to promote awareness and conservation of significant gardens and cultural landscapes through engagement, research, advocacy and activities.

The theme for this year was 'Gardening in the Driest State', with some of our visits and presentations related in some way to how gardeners/gardens past, present and future have coped/will cope with SA's tough climate.

The branch has circulated five newsletters in 2016 – 17, with Ray Choate as editor assisted by Elizabeth Ganguly. The current editorial team is Pamela Mayer, Elizabeth Dobson and Pamela Tonkin and a 'cutting edge' new look newsletter called *POLLen and DiRT* is currently in production.

Andrew Plumer our new treasurer has been extremely busy revising the branch accounts and bringing all our banking online. This has made it a lot easier to pay accounts – no more chasing around getting two signatures on cheques or having to make a trip to the bank to deposit cheques.

The SA branch is now using online booking via TryBooking for any events that involve a financial outlay. This will mean that members and guests are required to make a payment at the time of booking a ticket for the event. The use of online event booking brings SA in line with other state branches and by providing members with a committee phone contact any problems are easily solved.

- Tour to Victoria for nine days, visiting gardens around Beechworth, the Dandenongs, the Mornington Peninsula and Jindivick. We were very pleased to welcome seven travellers from other AGHS branches.

#### **ADVOCACY**

A letter was written to Wingecarribee Shire Council expressing concern over the future of an avenue of *Quercus palustris* and a row of heritage camellias, which are threatened with removal due to the planned upgrade of Station Street, Bowral. The pin oaks form the entry into Bowral, and the camellias form a unique collection that represents an important part of the garden history of the Southern Highlands. A plan has just been received by Wingecarribee Shire Council and community consultation should soon take place.

#### Submissions made to:

Wingecarribee Shire Council objecting to the proposed siting of additional villas being built on an adjoining property to Milton Park Estate. These would have interfered with the visual connection between iconic parts of the Milton Park garden and its rural vistas, which are a distinct characteristic of the Estate. Council rejected the villas in question.

Wingecarribee Shire Council objecting to a tourist development in Sutton Forest, due to the form and appearance being unsympathetic to, and intrusive in, the Sutton Forest cultural landscape. The proposal was withdrawn.

NSW Department of Planning and Environment re the Hume Coal Project EIS, requesting the project be refused due to unacceptable risk to the groundwater table and the landscape of Sutton Forest.

#### **PROJECTS**

The 'Sorensen Industrial Landscape Project' is ongoing.

#### SOUTHERN HIGHLANDS CHAIR'S REPORT

- A letter congratulating Dr Peter Watts (founding member of AGHS) on his award of Honorary Doctorate from the University of Melbourne

- Saumarez was acknowledged with an award at the 2017 National Trust of Australia (NSW) raising the profile of garden history.
- Chau Chak Wing Museum a submission on the Department of Planning's Major Projects site in response to the exhibition of the proposed building on the exceptional landscape opposite the Great Hall at the University of Sydney and the environmental impact statement that supports the development. The AGHS strongly recommends that the proposed building not go ahead and that the Minister and the Heritage Council reject the proposal.

After lunch we visited the gardens at

# Treasurer's Report

This year the accounts of the Society show a favourable surplus of \$54,354.

Significant income accounts have been subscriptions \$93,000, the Canberra Conference \$82,400, and Interest of \$16,300.

The conference in Canberra was enjoyable and a financial success and our thanks go to Margie Bourke, Sue Byrne, Helen Elliot, Kay Johnston, Greg Johnson, Nancy Clarke, Judy Pearce, Sue Tuisk, Marie Wood for all their hard work and resulting surplus.

Trisha Dixon organised pre- and post-conference tours that delighted members who travelled with her. Although this year's income was small, the Society appreciates the efforts Trisha makes on its behalf. Indeed, the National Management Committee values the work done by all the volunteers who manage the conference and tours.

The operational costs of the Society are \$204,000 annually. Subscriptions contribute less than half this amount. The journal was produced for \$71,000. \$6000 expenses were incurred on the New Zealand conference before it was decided it was not viable to proceed in 2017.

The redesign of the website now shows the National body represented by a visually stimulating and user-friendly site, costing approximately \$7000. \$5000 was allocated to the development of a revised and electronic version of a *Course Guide on Recording Your Garden* by writer Eliot Cooper. The Western Australian Branch was assisted by matching their contribution of \$5000 for restoration work in Queen's Park, Albany. \$9000 allowed the Society to become principal sponsor of *The Planthunter*'s HERITAGE issue in May 2017. Four stories relevant to AGHS were featured. This promotion gave the society exposure to new and wider audiences and links with social media.

Branches undertook other projects for approximately \$46,000. Details of these are given in the Branch Reports.

The Kindred Spirits Fund has a balance of \$206,000. The fund has supported the following publications:

- John Dwyer's publication Weeds, Plants and People (\$5000 \$1250 has been returned following sales)
- Sandi Pullman's research project on Ina Higgins (\$2000)

The resources of the Society are used to fulfil its objectives and input from the members is valued.
