


Managing an historic garden

You can't conserve what you don't understand:

- What matters / is significant? / should be kept?
- What can change / doesn't matter / isn't
- <u>Layout</u> to keep / <u>design</u> elements to keep
- ... plants of significance (typical, rare)...
- ... built elements of significance (" / ")
- Character not wrecking historic 'feel': how?

STEP 1 Assess Cultural Significance

- · collect information about the place
- analyse information including comparison with other places
- · decide what is significant about the place

STEP 2 Develop Conservation Policy and Strategy

- collect information about the issues affecting the future of the place
- · analyse information and consider options
- prepare a conservation policy which addresses all the issues
- decide upon a conservation strategy to carry out the policy

STEP 3 Carry out the Conservation Strategy

Step 1 is explained in the *Guidelines to The Burra Charter: Cultural significance* and Step 2 is explained in *Guidelines to The Burra Charter: Conservation Policy*.

- Ask for a copy of the LEP local heritage listing sheet understand what and why your place is heritage-listed – does it include the garden – layout / front & back / trees?
- Prepare a heritage impact statement focussed on the heritage values of the place.
